CORRIGENDUM

With reference to e-Tender Notice No. C(IV)-20/2014-15 /2438/SWC, dt. 02.03.2016 (Tender Id : 2016_WBSWC_72905_1) published on : 02.03.2016.

Please read the changes at Point No. 08.2, Clause No. 3.1.4, Clause No. 3.1.5.1 in Technical and Clause 3.1.5.3 in Financial as follows :

(Point 08.2)

Average Annual Turnover
(Notice Inviting Tender) : Average Annual Turn Over from Contracting business for the past 5 (Five) Financial Years should be equal to or more than ₹ **400.00 Lac** from Contracting Business..

Clause 3.1.4.

Average Annual Turnover - Technical :

Average Annual Turnover during last 5 (five) years should be more than ₹ **400.00 Lac per year.**

Clause 3.1.5.1- Technical : The Agency should have successfully executed similar nature of work having work order value of at least i.e. **Rs. 400.00 Lac (Four Hundred Lac) per year during last five Financial years.**

or

have successfully executed / executing **2 Nos.** similar nature of work having work order value of at least i.e. **₹ 400.00 Lac (Four Hundred Lac) per year** each during the last **Five** Financial years from the date of NIT in any Government/Semi Government /Undertakings/ Autonomous/ Statutory bodies/ Local Bodies/Reputed Bank or Reputed Corporate Company. Completion Certificate or Payment Certificates shall have to be produced in support of the credential. Credential of sub-contract work will not be acceptable.

NOTE: Similar nature of work:

Providing security service and guarding arrangement.

For running work, Copy of the Work Order having details of similar nature of job Work Schedule and Payment Certificate (cumulative payment received against a single work order) having the requisite work done value of the similar nature of work shall have to be submitted along-with the Payment Certificate, in the technical bid for verification of the credential.

Clause 3.1.5.3 - Financial : The average Annual Turn Over from contracting business for the last Five financial years of the firm should be more than **Rs. 400.00 Lac (Four Hundred Lac)** of the aggregate cost of works in **which the contractor intends to participate. Annual Turnover statement shall be in addition to the Audited Balance Sheet of the last three financial years authenticated by Chartered Accountant.**

Point No 3 in Tender Form

(Performance Certificate) : Performance certificate for last Five years instead of last Three years.
