**TERMS & CONDITIONS OF TENDER**

1. Reputed Contractors having experience of work with government bodies/ large Public Undertakings/ Private Companies & having sound financial capabilities having trade licence shall only be eligible to apply for tender.

The parties who have executed at least one similar contract of value not less than 10 lakhs.

2. Details of works carried out during the last 3 years giving particulars about the Name of client, value of works & period of contract.

3. Details of works in progress at present.

4. Bankers report regarding financial capacity.

5. A copy of the latest Income Tax, Professional Tax, Service Tax certificate.

Registered Labour contractors of Co-operative societies who furnish their latest Certificate all the Tenders duly attested by the registered of Co-operative Societies along with resolution passed by the society to participate in the tender.

Regarding eligibility criteria all credentials of tenderers will be verified on spot only after opening of tender quotations on the stipulated date and time. A copy of tender form will be displayed on the Notice Board which should be read before formally applying for Tender Form on payment of **Rs. 500/-** in cash. An **A/c payee Bank Draft for Rs. 25,000/-** drawn in favour of **West Bengal State Warehousing Corporation** on any Nationalised Bank must be deposited as earnest money along with Tender Form. Eligible Contractors should submit their Tender documents duly filled in, a sealed big envelope superscribe as **“Sealed Tender for appointment of Handling & Transport Contractor”** and should be addressed to **The Storage Officer, WBSWC at 6A, Raja Subodh Mullick Sqr. The tenderers shall submit technical bid and rate bid separately in two separate sealed envelopes superscribing the name of the warehouse for which tender is floated and the name & address of the tenderers should be mentioned on the said envelopes. The two envelopes should be kept in one big envelope as mentioned above and be dropped in the Tender box as per rule and tender notice.
