(i) A Bank Draft from any Nationalised Bank for the auction proceeds i. e. the highest bid amount offered by the highest bidder in auction in favour of **West Bengal State Warehousing Corporation** non compliance of which will lead to forfeiture of Earnest Money submitted.

(ii) A transit pass will have to be collected from the concern Forest Range Office at his own cost and initiative.
