ORDER

West Bengal State Warehousing Corporation was transferred to Food & Supplies Department from Public Enterprises Department with effect from February, 2014. Since then the workload of WB SWC has been increased considerably as the work of construction and maintenance of Government godowns & other infrastructural works have been entrusted to them. As a result the officers of SWC have to come from the office of SWC at Raja Subodh Mallick Square every now and then to the Directorate and Secretariat offices of Food & Supplies Department at Mirza Ghalib Street.

To sort out the problem an arrangement was earlier made to accommodate the higher officials of WB SWC at the 1st Floor of Main Building of Khadya Bhaban as an interim measure.

Now it is felt that the office of WB SWC should be shifted at Khadya Bhaban campus for better coordination with the Department and its Directorate to carry out the developmental schemes and other functions of PDS and procurement operation of the State.

Now the undersigned is directed to say that the office of SWC will be shifted to the 2nd floor of Block-B at the space presently being occupied by WB ECSC Ltd for an area of around 2000 sq.ft. Also a space of 2000 sq.ft. at the 3rd floor of the Block-B of Khadya Bhaban is allocated to WB SWC for which some re-allocation of space of the Directorate of Statistics/Textiles & PDS/Rationing will be required.

MD SWC is requested to arrange for shifting of his office immediately. Renovation work, if necessary, may be undertaken by WB SWC by taking up with Executive Engineer, PWD, Kolkata East Division and Executive Engineer, PWD, Kolkata Central Electrical Division.
