In partial modification of G.O No. 727 (Sanction)-FS dt. 17.12.2015, G.O. No. 72-FS dt. 05.01.2017 and G.O No. 2685 FS/P/Sectt/GE&EM/4M-15/2015 dt. 28.08.2017, the Governor has been pleased to make the following order:

WBSWC shall be entitled for engagement of H&T contractors, with the approval of the Food & Supplies Deptt., at GFD Cossipore and GFD Bagrakote [only at those godown sheds of GFD Cossipore and GFD Bagrakote that will be offered by WBSWC to District Controller(s), F&S, and will be utilised by the District Controller(s), F&S for procurement operations] at their adopted schedule of rates and for **reimbursement of actual cost of handling & allied operation together with 15% supervision charges with retrospective effect from 17.12.2015 and 05.01.2017 for GFD Cossipore and GFD Bagrakote respectively.**

Claim bills as raised by H&T contractors for H&T operations at GFD Cossipore and GFD Bagrakote shall be verified and endorsed by the Godown-in-Charge of GFD Cossipore and GFD Bagrakote before sending the same to the District Controller, F&S concerned. The District Controller, F&S, after examination of the same shall forward the bills, with his comments, to the Director, Directorate of Finance, F&S Deptt. The Director of Finance, in turn, after necessary examination of claim bills shall arrange for placement of fund towards payment of actual H&T charges plus 15% supervision charges in favour of M.D., WBSWC who will disburse the actual H&T charges to the H&T Contractor concerned.


WBSWC will supervise the job of preservation and quality control management of stocks as performed by the Handling Contractors at GFD Cossipore and GFD Bagrakote and will be entitled for **reimbursement of actual charges as claimed by the Handling contractors for such operation in terms of guideline of Memo. No. 510 (18)/FP/IL-09/2015 dt. 18.09.2015 of the Director, D.D.P&S, together with 15% supervision charges with retrospective effect from 17.12.2015 and 05.01.2017 for GFD Cossipore and GFD Bagrakote respectively.**

Claim bills for preservation and quality control of stocks at GFD Cossipore and GFD Bagrakote shall be raised separately by the H&T Contractors as per prescribed proforma of the Director, Directorate of Finance. These bills should be verified by Q.C Inspector and Godown-in-Charge of GFD Cossipore and GFD Bagrakote before sending the same to concerned DCF&S(s). The DCF&S(s) shall forward the same to the Director, Directorate of Finance, F&S Deptt. The Director of Finance, in turn, after necessary examination of claim bills shall arrange for placement of **actual admissible preservation & quality control charges** (in terms of guideline of Memo. No. 510 (18)/FP/IL-09/2015 dt. 18.09.2015 of the Director, D.D.P&S) plus 15% supervision charges in favour of M.D., WBSWC, who will disburse the actual admissible preservation and quality control charges to the H&T Contractor concerned.

Further, WBSWC is entitled to get reimbursement of storage charges at CWC rate for the period from 17.12.2015 to 31.08.2017 in respect of only those godown sheds of GFD Cossipore that were offered by WBSWC to the District Controller(s), F&S and were utilised by DCF&S(s) for procurement purposes and for the period from 05.01.2017 to 31.08.2017 in respect of only those godown sheds of GFD Bagrakote that were offered by WBSWC to District Controller, Darjeeling and were utilised by the District Controller, Darjeeling for procurement purposes.


Further, in supersession of the provision as laid down in G.O No. 727 (Sanction)-FS dt. 17.12.2015, G.O. No. 72-FS dt. 05.01.2017 and G.O No. 2685 FS dt. 28.08.2017 regarding handing over of administrative jurisdiction of GFD Cossipore and GFD Bagrakote to WBSWC, the Governor is pleased to order that only the managerial control of the GFD Cossipore and GFD Bagrakote is hereby handed over to WBSWC instead of administrative control over GFD Cossipore and GFD Bagrakote. The GFD Cossipore and GFD Bagrakote shall administratively be controlled by the Food & Supplies Department until further order.

This order will take an immediate effect.
