ORDER

The undersigned is directed to state that a project has Construction of one Warehouse of 20,000 M.T. capacity at Haldia was sanctioned by NABARD under Nabard Warehousing Scheme, 2014-15 at an approved project cost of Rs. 1422.67 lakh.

The DPR of the project was prepared on basis of P.W.D. Schedule.

The in its 38th meeting on 04/02/2014, High Level Committee of FCI approved 20,000 M.T. capacity warehouse under PEG Scheme at Haldia to be built-up by W.B.S.W.C. on their own land with the benefit of assured hiring for a period of at least 9 years.

This Department accordingly revised the DPR as per specification and schedule followed in FCI for Construction of Warehouses and the estimated cost increased from Rs.1422.67 lakh to Rs. 2407.65 lakh. Nabard did not sanction to additional cost arising out of escalation and advised to meet up the excess cost from the State Budget.

This Department moved to Finance Department for getting their concurrence in this regard and Finance Department has accorded approval towards the revised estimated cost of Rs. 2407.85 lakh for construction of an aggregated capacity of 20000 MT at Haldia and agreed to release the balance fund of Rs. 985.18 lakh as 69.25% additional cost over and above the estimate sanctioned by NABARD under RIDF from the State Plan fund.

Under the circumstances the undersigned is now directed by order of the Governor to say that Governor is pleased to accord administrative approval to the Scheme "Construction of godowns of an aggregated capacity of 20000 MT at Haldia" to be built up by W.B.S.W.C. at an estimated cost of Rs. 2407.85 lakh.

Out of the total amount of Rs. 2107.85 lakh an amount of Rs. 1351.54 lakh will be met from WIF loan of NABARD under NWS- 2014-15, Rs.71.13 lakh under State budgetary allocation under RIDF Head of Account, and balance amount of Rs.985.18 lakh will proceed from State Budget Provision under other godown-related Heads of Account.

This issues with the approval of Principal Secretary, Food and Supplies Department and in accordance with Finance Department U.O. No.: Gr. $\Gamma/2015-16/0673$ dated 08.12.2015.
