It is noticed that the applications for appointment on compassionate ground are being submitted by the applicants beyond the time limit due to their lack of knowledge about the requirements and formalities are to be completed by them. In clause 10(bb) [added to Notification No. 251-EMP, dated 03-12-2013 vide Notification No.26 EMP, dated 01-03-2016], it is mentioned, "The concerned authority in the Department / Office should meet the members of the family of the deceased Government Servant immediately after his/her death to advise and assist them in getting appointment on compassionate ground. The applicant should be called in person at the very first stage and should be advised in person about the requirements and formalities to be completed by him." Sometimes it is also noticed that the field offices and concerned Directorates are taking much time in processing / forwarding the cases though the applicants submitted their applications within the prescribed time limit. In clause 10(dd) [added to Notification No. 251-EMP, dated 03-12-2013 vide Notification No.26 - EMP, dated 01-03-2016], it is mentioned, " All cases of compassionate appointment should be disposed of by the administrative Department preferably within six months of the receipt of report of the 03 (three) member screening - cum - enquiry committee."

In view of the above facts, all the Directors/Officers are hereby instructed to issue necessary instructions /directions to their field offices to comply with the directives given in clause 10(bb) of the Notification No. 26-EMP dated 01-03-2016 . The Directors/Officers will also follow the directives given in clause 10(dd) of Notification No.26-EMP dated 01-03-2016 and will forward the cases for appointment on compassionate ground to the Department within a period of 03 (Three) months from the date of receipt of the report of the 03 (Three) members -screening - cum - enquiry Committee.

All concerned are directed to comply with this order with an immediate effect and any deviation will be viewed very seriously.
