- 19. The successful bidder shall maintain the security and safety of the labours, users of the concerned office. Safety of the other structures are the responsibility of the bidder.
- 20. Intending bidder must have to possess the mechanical devices as required for dismantling and running such machineries & vehicles. Original documents in this respect have to be uploaded in the e-Auction.
- 21. Dismantling of structure will be made through machinery (proclaim or equivalent) instead of manually by deploying santaras.
- 22. The successful bidders at his own cost has to adopt all safety/preventive/precautionary measures following relevant rules of the Government for safe dismantling and disposal of all components of the structure. Permission from appropriate authority if needed for such process has to be procured from the end of the bidder at his own cost failing which the security deposit of the bidders will be forfeited and the matter will be sole responsibility of the bidder. WBSWC will be in no way responsible in case of violation of any rule/ law as has been enforced by the govt. or any local authority such as Municipality etc.

25. Any damage or loss of Government/public/private property or life during the dismantling/disposal process will be the sole responsibility of successful bidder and the successful bidder has to replenish the cost of such damage at his own cost failing which the security deposit of the bidder will be forfeited. Disposal of the dismantled materials have to be arranged as per relevant traffic rule of the area. All such incidental cost has to be considered during the quoting their bid/offer. ....CONTD/3

26. A certificate indicating the works have been completed in all respect and the site has been cleared thereof and no damage to any Government property has been occurred during such process must be obtained from the Superintendent, Tarakeswar Warehouse godown for release of the security money. Permission of disposal of garbage in area under any local authority has to be obtained by the bidder and necessary fees has to be borne by him, if any.

27. The SUPERINTENDING ENGINEER West Bengal State Warehousing Corporation. Reserves the right to cancel the NIB due to unavoidable circumstances and no claim in this respect will be

entertained.

- 28. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that quotationer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.
- 29. In case if there be any objection regarding Prequalifying the Agency that should be lodge d to the Chairman Screening Committee within 48 hours from the period of publication of list of qualified Agency and beyond that time schedule no objection will be entertained by the Screening Committee.
- 30. Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the successful quotationer if found necessary. After verification, if it is found that such documents submitted by the successful quotationer is either manufacture or false in that case, work order will not be issued in favour of the quotationer under any circumstances.
- 31. Constructional Labour Welfare Cess @ 1(one) % of cost of construction will be deducted from every Bill of the selected agency, CGST, SGST, Royalty & all other Statutory levy/ Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.
- WBGST and CGST rates will be applicable while making payment to the contractor in accordance with the No. 5050-F(Y) Dated: 16.08.2017 of Audit Branch Finance Department, Govt. of West Bengal. The taxable value of the work will also be determining as per this govt. order or any other govt. Orders in vogue or as will be issued by the govt. from time to time in this regard in future. The work may be modified as per govt. order keeping the total value as tendered as a maximum.
- 33. Statutory Deduction by way of income tax, GST, LWCess to be made at per existing rule in vogue. Besides this 10% Security Deposit will be deducted from the final bill of the successful bidder and will be released after 3months from the date of completion of the work.

#### 35. Qualification Criteria

- c) Experience

The eligibility of a bidder will be ascertained on the basis of the attested documents in support of the minimum criteria as mentioned. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/ tenderer/ quotationer will be out rightly rejected at any stage without any prejudice with forfeiture of earnest money forthwith.

36. Agencies failed to complete any work under WBSWC in stipulated time of Tender are debarred fromparticipation in this Bid. Any extension of time as may have been allowed by WBSWC is purely for getting the work done within the same tender by allowing extension of time as special aid to the contractor for the work. But this will not otherwise make the contractor eligible for this present work.

37. Agencies having works of WBSWC in hand to complete are debarred fromparticipation in this Bid.

38. Successful bidder will have to execute a formal agreement with W.B.S.W.C. upon Standard Contract from of WBSWC of Rs. 750 stating there in to abide by all the clauses and sub clauses of the aforesaid NIB.

After opening of financial Bid if it is found that the lowest bidder has submitted an amount which is less than 2% of his bid value he has to submit the balance amount in Bank Draft of any nationalised bank drawn in favour of the West Bengal State Warehousing Corporation payable at Kolkata against the work otherwise his offer will be treated as cancelled.

If the dates fall on holidays or on days of bandh or natural calamity, the dates defer to next working days. Superintending Engineer, WBSWC reserves the right to refuse permission any serial or total serial of any applicant without assigning any reason whatsoever and no challenge against such refusal will be entertained.
