C I R C U L A R

It is hereby informed all concerned Zonal Officer(s) / Warehouse In-Charge(s) that a Cloud-based Application Software named Warehouse Management System (WMS) has been developed with the prime objective of building a real-time information sharing network between the Warehouses and Head Office of WBSWC. Training programs were arranged in this regard on through Zoom cloud Meetings, where all the concerned Zonal Officer(s) / Warehouse In-Charge(s) and Officials of Head Office participated and acquired knowledge on WMS, its functionalities and Module-wise operation.

As decided by the competent authority of this corporation the Software was launched for SWC and RIDF Godowns w.e.f 08.07.2020. Now the authority has decided to give access to In-Charges of GFD and PEG Godowns in WMS platform on which they will start working w.e.f. **19.08.2020**. Login IDs and Passwords of all concerned shall be shared separately through e-mail. It is also intimated that GFDs and PEGs are to use the **Fund, Notification & Survey Module only** till further order. The Zonal Officer(s) / Warehouse In-Charge(s) are requested to refer Module-wise brief description and section-wise responsibilities described in the circular(s) bearing Memo No. 4025/WBSWC-15012(12)/1/2019-GEN SEC dated 06.07.2020 and an order with FAQs bearing Memo no. 4170/WBSWC-15012(12)/1/2019-GEN SEC dated 22.07.2020, which were issued from H.O. and attached herewith.
