Consequent upon the E-Tender (3rd Call) invited by this office vide NIT No. 302/SWC dt. 10.05.21 and as per the technical & financial bids submitted by you, you have been selected as the lowest bidder for providing security service to all the godowns under Zones A(Municipal Area) & B(Panchayet Area) as stated in the annexure A & B (enclosed) including Head Office, RIDF, GFD and Private(hired) Godowns under W.B. State Warehousing Corporation with effect from 01/11/2021, at the rate as per Minimum Wages Act (i.e the rate of Unskilled worker as per Labour Department notification which may be changed from time to time)+ 001(One) paise (as service charge quoted by you) per head per month excluding GST for Zone –A (Municipal Area) & Zone –B (Panchayet Area).

You are therefore, awarded the Contract for providing security service to the godowns under Zone A & B as stated in the annexure A & B respectively (enclosed) including Head Office, RIDF, GFD and Private (hired) Godowns of the W.B. State Warehousing Corporation under the following terms and conditions:

- 1. Name of Work: Providing security service by deploying security guards including monitoring and surveillance at 55 location including Head Office, RIDF, GFD and Private Godowns of WBSWC as and where required basis under the Zone A & Zone B (as per annexure A &B). The number of locations and number of persons (unarmed security guard/ helper) as indicated in the Annexure A and Annexure B (for zone A & zone B) may be increased or decreased and any location may be totally omitted with 1 (one) month notice or 1 (one) month remuneration in lieu of such notice at the discretion of WBSWC without showing any reason therefore. In addition to the above, the number of location(s) for providing the security services may be increased by WBSWC at its discretion and you will be responsible to provide such security services at the above mentioned rate for the concerned zone within 1(one) month of the communication.

- 3. Duration of Work: 01.11.2021 to 31.10.2022.



- Duration of work may be extended by WBSWC for a further maximum period of 3(three) months beyond 31/10/2022 at sole discretion of WBSWC.
- 4. Interest Free Security Deposit: 10% of the Contract Amount to be paid within 15 days from the receipt of Work Order in the form of Demand Draft issued from any nationalized bank or Bank Guarantee of a Nationalised Bank in favour of the "West Bengal State Warehousing Corporation" payable at KOLKATA.
