6. Earnest money of Rs. 10,000/- (Rupees Ten Thousand) only in the form of Bank Draft drawn on any scheduled Bank payable at Kolkata in favour of West Bengal State Warehousing Corporation.



2. The Moisture Meters are to be delivered at godown point within 7 (Seven) days of issuance of delivery order. The quoted rate should be inclusive of all charges and no additional transportation charge will be allowed for supplying the equipment at the godown point.
3. GST will be allowed as per norms.
4. The rate of Moisture Meter should be mentioned both in words and figure.
5. Each quotation must be accompanied with an Earnest Money of Rs. 10,000/- (Rupees Ten Thousand) only in the form of Bank Draft drawn on any scheduled Bank payable at Kolkata in favour of West Bengal State Warehousing Corporation. Earnest money of the selected quotationer will be treated as security deposit that will be kept at the custody of WBSWC till completion of warranty period of last supplied Moisture Meter.
6. The lowest quotationer will have to give demonstration at the office of the WBSWC for verification of the specifications mentioned in the NIQ. After successful demonstration and verification of the specification, work order will be issued for supplying of the item for a period of 1 (One) year from the date of issuance of work order.
7. The Moisture Meters supplied should come with 2(Two) year's on-site warranty. Failure to comply with this condition within reasonable time may call for forfeiture of Security Deposit of the selected agency.

8. In case of any delay, alternative supplier may be engaged for such delivery and action will be taken against the supplier for which excess cost of alternative supplier may be recovered from the pending bills of the selected supplier.
9. Payment will be made after successful delivery of the item in good condition at the godown as per advice and submission of the bills duly countersigned by the concerned Superintendent/ Godown In-Charge(s).
10. The Managing Director, WBSWC reserves the absolute right to accept or reject any or all quotations including the lowest one without assigning any reasons whatsoever and the decision will be final and binding on all the quotationer.
