


Notice Inviting Expression of Interest

Terms and Conditions

- Participants must have experience in similar field in 3 years or more.
- The participants shall submit their offer in one sealed envelop mentioning the words on the top of the envelop "Quotation for Techno-Commercial Feasibility study at three different places to construct new godown" and containing two separate envelops one is "Technical Bid" and another is "Financial Bid" as per time schedule mentioned above.
- The documents must be attached with the Technical Bid are -

Details of the organization with contact details
Photocopy of valid Trade License
Photocopy of PAN
Photocopy of GSTIN certificate

- Price Bid termed as "Financial Bid"
- The participants should have Headquarter/Branch Office in Kolkata for urgent discussion.

- Technical Bids shall be opened first. Financial Bids shall be considered if the bidder qualified in Technical Bids. The Bidder quoted the lowest rate (L1) shall be selected for offering of engagement cum work order.
