## **Terms & Conditions**

1. The Agency should be empanelled by the Order of Finance Department, Govt. of West Bengal vide Order 3545-F(Y) dated 17.12.2020
2. The Agency should have all statutory documents such as PAN, GST Registration, and Professional Tax Registration etc.
3. The Agency should have Headquarter/Branch Office in Kolkata.
4. The Agency should provide a dedicated Nodal Officer/Relationship Manager
5. No TA/DA or any other allowance will be paid by WBSWC during visit of the Warehouses
6. The Valuation Report should be kept strictly confidential and should not be divulged to anyone and any deviation may lead to cancellation of appointment and/or debarring or blacklisting or any other penalty including financial one may be imposed as deemed fit by WBSWC.
7. The quoted rate shall be fixed and shall not be revised unilaterally on any account throughout the contract period.
8. The person signing the Tender document or certify the inventory and valuation report thereafter shall warranty that he/she has authority to sign such document.
9. WBSWC reserves the right to accept / reject /cancel the tender at any point of time without assigning any reason. Incomplete tender, conditional tenders, tender received late or tender not confirming to the terms and condition mentioned in the Tender documents will be rejected.
10. During the evaluation of the financial bids of the empanelled bidders, if it is found that more than one bidder quoted the same rate, the selection will be made on the basis of draw of lot and that shall be final and binding on the bidders.
11. Bidder quoting lowest price (L1) will be selected (subject to other terms & condition). If L1 bidder does not accept the offer of appointment within seven days of receipt of offer the offer will be cancelled and L2 bidder will be treated as L1 bidder & so on and if L2 does not accept quotation of L1 within 5 days, L3 bidder will be given such offer & so on.
12. In case of any dispute arising during execution of contract, an amicable solution may be arrived at with discussion and reconciliation. However, in case of any dispute remaining unresolved, decision of the Managing Director, WBSWC, will be final and binding on both the parties to the Contract.
13. The Valuer will inspect the goods in the presence of the WBSWC and Customs Officials at the respective location where goods are stored.
14. The Valuer shall complete the valuation work, including submission of valuation certificate, within 10 days from the date of inspection.
15. The Work Order will be issued to successful bidder, which will remain valid for 180 days from the date of awarding the contract. The contract may be extended for further 180 days on the same rate, terms & condition on mutual consent in writing of the Valuer. This Corporation reserves the right to appoint any other Valuer for the same job if L1 Bidder

fails to complete the job satisfactorily. Corporation may have liberty to terminate the Valuer at any time with one month prior notice due to unforeseen administrative reason or unsuccessful completion of the job within the stipulated time frame as decided.

16. No right exists for the approved Valuer to claim that they alone should be entrusted with the valuation of the goods. This Corporation is free to employ L2 Valuer with unsatisfactory work of L1 Valuer.

17. Further while undertaking the valuation, the Valuer is to comply with the following

- The valuation report submitted by the Valuer shall specify **(a)** present market price and **(b)** margin of profit.
- The Valuer shall provide full details of the basis of valuation in their report including physical description and condition of the goods.
- The Valuer shall be responsible for the findings / suggestions/implications of their report on the assignment allotted to him/her.
- The Valuer shall take all necessary steps including taking samples if considered necessary or physical or chemical testing at their own cost to ascertain the correct valuation.
- The Valuer shall maintain secrecy of the work assigned to them and their report on valuation. They will not divulge any information that may come across at any state of valuation to others in detriment to the interest of the Corporation.

20. On receipt of the bill from the individual Valuer the same will be processed and payment will be made after making necessary deduction towards dues, penalty, income tax, statutory deduction if any after due verification.
