

Minutes of the meeting of Tender Committee held on 21/12/2022

After uploading of technical evaluation sheet of the tender for selection of H&T contractors at different WBSWC managed godowns issued vide no. 254-C(IV)-398/RIDF/SWC Dated 23.09.2022, some of the bidders (viz. Sardarpara Handling Contractors (P) Ltd., Chenaram Choudhary, Ashok Kumar Sarkar, JPG Agritech Pvt. Ltd., Tapas Mohanta and Aaradhya Enterprise) of Rajganj RIDF, GFD Dabgram, NJP RKVY, GFD Bagrakote, Hanskhali RIDF, Krishnagar RIDF and Tehatta RIDF godowns raised complaints against some bidders (Firdose Alam Ansari, Toton Saha, Kamal Sharma, Kamal Mangar, Ramanad Roy, Nazirpur Samabay Krishi Unnayan Samiti Limited and Aishmali Large Sized Primary Co-operative Agri Credit Society Limited) of the godowns mentioned hereinbefore. Based on the complaints received from those bidders as well as the decision of the last Tender Committee meeting held on 28/11/2022, some of the bidders who have not uploaded some statutory documents either mistakenly or not in prescribed format were asked to submit those documents to the Head Quarter of WBSWC within 7 (seven) days for taking next course of action.

After scrutinizing the documents further received from the bidders as well as considering the merits of the complaints, the following decisions have been taken by the Tender Committee:
