Terms and conditions

- The interest bidder / depositor should quote their rate of storage charges on per MT per month basis only.
- After selection of the bidder, WBSWC will carry out the necessary repair-maintenance works at its own cost.
- The godown will be offered for commercial use for 3 years from the date of occupation of the said godown. In case if the depositor wants to continue to occupy the godown space after the expiry of the storage contract period of 3 years the same may be granted subject to the approval of the authority of WBSWC only. In case of non approval for such extension of contract, the depositor shall be bound to vacate the godown on the date of expiry of the storage period. However in case of approval of extension of contract beyond the initial period of 3 years, there will be an escalation of storage rate by 20%.
- Nature of allotment will be purely on self – operation basis.
- No hazardous, inflammable articles will be allowed to store in the said godown in any manner.
- The user will arrange all other facilities like insurance, security arrangement, day to day expenses.
- User must pay electricity bill and internet bill received from the concerned authority from time to time.
- The user will ensure routine cleaning & upkeeping of the premises and shall be liable to make payment of the damages if caused on its part during the operation of the godown.
- Payment of storage charges should be made within 7 days from the raising of storage bill from the end of Head Office, WBSWC.
- **WBSWC will accept the rate quoted by the bidder / depositor if it is found suitable only. WBSWC is not bound to accept the highest quoted rate if the same is found unsuitable and decision of the authority of WBSWC in this regard shall be final and binding.**
