Sub: Cancellation of candidature as bidder in the e-tender for selection of H&T contractor for  
NJP RKVY and Rajganj RIDF godowns.

Whereas e-tender for appointment of H&T Contractor at NJP RKVY and Rajganj RIDF godown was floated;

And

Whereas after scrutinizing the documents of bidders by the Tender Committee he was declared as technically qualified for both the godowns;

And

Whereas financial bids of the technically qualified bidders were opened for both the godowns and observed that he was declared as L-1 bidder of the NJP RKVY godown as per Clause-8.1.9 of the tender document having highest value/ volume of handling work entrusted by the Government;

And

Whereas Before issuance of work order in favour of him, one of the technically qualified bidders, forwarded a copy of letter bearing no. HTC/ATTPL/FCI/COB/ CONT/VOL.2/22-23 dated 27/02/2023 issued by Divisional Manager, FCI, DO Coochbehar wherein it has been mentioned that previously issued credential certificate vide no. Nil dated 15/10/2022 & certificate no. FCI/DO/COB/ CONT.CORRES/22-23 dated 02/12/2022 are not authentic and shall be treated as "INVALID";

And

Whereas Based on the said letter, the Divisional Manager, FCI, DO Coochbehar, was requested to confirm whether the letter vide no. HTC/ATTPL/FCI/COB/CONT/VOL.2/22-23 dated 27/02/2023 has been issued from his end and also to confirm whether Sri Totan Saha has been engaged as an

H&T Contractor from his end vide this office letter no. 3902-L(II)-269/SWC/2023 dated 01/03/2023 and the copy of the said letter was also served to him with request to send relevant documents in support of his appointment as H&T Contractor issued by FCI, DO Coochbehar;

And

Whereas FCI authority, in reply, has intimated that Sri Totan Saha is only signatory authorized by its Director, Sri Anup Kumar Jasrasaria of M/s Anup Trade and Transport Pvt. Ltd. which is the H&T Contractor of NCB Railway siding to depots under FCI, DO Coochbehar vide letter dated 09/03/2023. However, it appears that no reply has been received from his end;

And

Whereas from above facts and circumstances, it transpires that he is not an H&T Contractor at all and uploaded an unauthentic credential certificate (one of the most vital documents required to be qualified technically) for which the whole tender process has been vitiated. Further, he failed to respond to this office letter vide memo no. 3902-L(II)-269/SWC/2023 dated 01/03/2023.

Hence, the Tender Committee of WBSWC has decided that as per clause 6.2 of the tender document his candidature for appointment of H&T Contractor at NJP RKVY and Rajganj RIDF godowns is treated as cancelled.
