E rules for obtaining permission from the Executive Engineer (Electrical), WBSWC. Before Technical Evaluation Tenderer must produce all original documents for verification if required. Liability period one year after the successfully completion of work. S.D. Money may be released after one year the successfully completion of work.

Earnest money in the form of eligible instruments as per rule duly pledged in the shape of Demand Draft in favor of West Bengal State Warehousing Corporation payable at Kolkata must be deposited along with the tender, VIII<sup>th</sup> Issue of NSC cannot be pledged as Earnest Money as per postal rule.
